



Terms of Payment: All orders are either COD or bank approved checks unless prior credit has been approved. We accept all credit cards. Add 3% for Credit Card payments.

Credit terms are net (30) days from date of invoice unless otherwise indicated. A service charge of 1.5% per month will be assessed each month after the initial 30 day period has expired until payment is received. In the event of nonpayment, the buyer agrees to bear the expense of all legal proceedings plus any reasonable attorney fees.

Venue: The contract shall be governed by and construed in accordance with the laws of the state of North Carolina.

Taxes: Taxes are not included in the sales price. Any taxes, if applicable and imposed by any present or future local, state or federal agency must be paid by the Buyer.

Warranty: No express or implied warranties as to the goods sold extends to the buyer other than the manufacturer's warranty.

Claims: The responsibility of the ceases upon delivery of material in good order to the carrier. As all goods are shipped at buyer's risk, any claims for damage or shortage or loss in transit must be filled by the buyer against the transportation company. (We will assist the buyer in any reasonable way possible in the filing and collection for any claim for damages and/or losses while in transit.) Claims against shortage will not be considered unless made within 60 days after receipt of goods.

Return Of Goods: Goods may not be returned except by permission of a representative of Seismic Control & Isolation, Inc., and when so returned, shall be subject to a restocking fee. No goods may be returned after 90 days.
